Subject: Detention of Palestinian human rights defenders by Israel

Dear Baroness Ashton,

We are writing to express our deep concern regarding Israel's repression of grassroots movements in the West Bank, in particular the arrest and imprisonment of Palestinian human rights defenders, and to urge you to do everything within the EU's influence to help free three human rights defenders that the Israeli authorities are holding as political prisoners.

On 16 December 2009, an internationally known and respected Palestinian human rights defender, Jamal Juma', was arrested by Israeli Authorities. Prior to his arrest, Mr. Juma' had been active in raising awareness of the situation of Palestinian human rights with EU officials and diplomatic missions in Israel/Palestine and he has participated in many European Union and United Nations conferences on Palestine. Mr. Juma' – who is coordinator of the Palestinian Grassroots Anti-Apartheid Wall Campaign (Stop the Wall) – has been subjected to the military court system, which does not comply with international standards of fair trial and due process. He was denied access to his lawyer for nine consecutive days following his arrest. On 7<sup>th</sup> January 2010 a military judge authorized a further six day extension to Mr. Juma's detention, purportedly to allow time for more investigation, despite the authorities having already held him in custody for over three weeks without any charge and having ceased questioning him last month.

The arrest of Jamal Juma' is part of an intensive wave of Israeli repression against human rights defenders and anti-Wall activists protesting against the Wall, and its associated unlawful regime, who in light of Israel's non-compliance with the International Court of Justice's advisory opinion of July 2004 on the legal consequences of the Wall, were left to defend their human rights alone. They did so by mobilizing an international solidarity movement against the Wall and by increasing their international advocacy efforts, liaising with various United Nations agencies and participating in international speaking tours.

On 22 September 2009, Mohammad Othman, a youth coordinator with the Stop the Wall Campaign, was arrested and placed under administrative detention, without charge or trial, after 61 days of harsh interrogation proved no criminal activity. No external evidence was brought to the attention of the court and the military prosecutors were unable to formulate substantiated allegations or charges against him.

On 10 December 2009, Abdallah Abu Rahma, the Head of the Popular Committee against the Wall and Settlements in Bil'in, was also detained for his role in mobilizing demonstrations against the Wall.

In response to increasingly organized advocacy efforts and grassroots protests, the villages affected by the Wall and Israel's annexation policies have been subjected to arrests, intimidation, threats and killings and, at times, collective punishment. Far from being incidental to lawful measures to maintain public order, these developments, including the excessive and often arbitrary use of force, constitute a systematic policy intended to isolate, contain and suppress civil resistance to the Wall and Israeli occupation.<sup>1</sup>

The European Union has clearly defined regulations demanding the respect of international law and human rights in third countries. The EU is also committed to promote this respect, in particular as regards ensuring the protection of human rights defenders, pursuant to EU Guidelines.<sup>2</sup> All agreements with Israel, including the EU Neighbourhood Policy, the EU-Israel Association Agreement and the EU-Israel Action Plan require mutual compliance with human rights standards and highlight that bilateral relations are based on a commitment to 'common values'. Indeed, Article 2 of the EU-Israel Association Agreement states: *"Relations between the Parties, as well as all the provisions of the Agreement itself, shall be based on respect for human rights and democratic principles, which guides their internal and international policy and constitutes an essential element of this Agreement."*

The EU Guidelines on the protection of human rights defenders are integral to this drive for compliance with human rights standards, as the following provisions make clear:

- 'the EU recognises that individuals, groups and organs of society all play important parts in furthering the cause of human rights.'; and
- 'the EU acknowledges that the activities of human rights defenders have over the years become more widely recognised. They have increasingly come to ensure greater protection for the victims of violations. However, this progress has been achieved at a high price: the defenders themselves have increasingly become targets of attacks and their rights are violated in many countries. The EU believes it is important to ensure the safety of human rights defenders and protect their rights'.

Indeed, the arrest and subsequent treatment of Palestinian human rights defenders is a particularly strong indication that Israel lacks the necessary commitment to 'respect for human rights and democratic principles' stipulated under the Association Agreement and Action Plan. Such treatment also highlights substantial problems within the Israeli judicial system, including the existence of and arbitrary recourse to a military court system that does not comply with international standards of fair trial and due process and which many

observers now consider to violate the concept of temporary military law over civilians resident in occupied territory as allowed for under the law of belligerent occupation.

In order not to weaken the perception of the European Union's own commitment to its noble values, we ask you:

- to raise your concern about the cases of Jamal Juma', Mohammad Othman and Abdallah Abu Rahma and other human rights defenders in public statements and in your talks with Israeli officials.
- to mandate diplomats of the European Commission to provide "visible recognition for human rights defenders and their work, through appropriate use of the media", as recommended in the EU guidelines on the protection of human rights defenders.
- to review existing agreements and condition any future negotiations and action plans with Israel on its upholding of international law and respect for human rights, including its cessation of the harassment and detention of human rights defenders and respect for the advisory opinion of the International Court of Justice on the illegality of the Wall. The adoption of this opinion through UN General Assembly resolution ES-10/15 has been fully supported by the European Union.

We look forward to hearing back from you at your earliest convenience.
